Sir,

In producing herewith arrested accused person namely Sadhan Samanta aged 56 yrs s/o Lt. Prahallad Samanta of Uttar Baguan, P.S. Tamluk, Dist- Purba Medinipur along with the seized articles ten (10) liters LD liquors containing five plastic bottles each bottle two liters under proper seizure list under proper seizure list. I ASI Nandadulal Mahakul of Tamluk P.S. do hereby lodged complaint to the effect that on 04.04.2017 at 07.45 hrs. myself along with C/750 Jayanta Patra, C/473 Sahadat Mallik left P.S. to perform morning mobile duty vide Tamluk P.S. G.D.E. no. 165 dated 04.04.2017 and C.C. no 1344 dated 04.04.17. In course of morning mobile duty at Naikuri received information from my reliable source that one person selling I.D. liquor illegally at Chanserpur from open place. I contacted with two passersby namely (i) Asram Khan s/o- Lt. Banche Khan of Chansepur, Bazarpara, PS- Tamluk and (ii) Jabbar Sk. s/o- Sk. Sukuruddin of Barbaria, PS- Tamluk and request them to assist police and they agreed. We held raid at that at 08.35 hrs Chanserpur as identified by my source and apprehended the LD liquor seller in presence of witnesses as noted above. Search was made at the open place in presence of apprehended person, above noted witnesses and police party and found ten (10) liters I.D liquors containing five plastic bottles each bottle two liters kept in a nylon bag. Being asked the apprehended person disclosed his identity as Sadhan Samanta aged 56 yrs s/o Lt. Prahallad Samanta of Uttar Baguan, P.S. Tamluk, Dist-Purba Medinipur and on demand he fails to produce any valid license, papers, documents or challan for posses and sells I.D liquor to publics. I seized ten (10) liters I.D liquors containing five plastic bottles each bottle two kept in a nylon bag after preparing proper seizure list duly signed by the above noted witnesses and as well as the apprehended person. I took sample from seized article and labeled it also. I arrested the apprehend person Sadhan Samanta, issued memo of arrest and informed him ground of arrest. During local enquiry it is crystal clear that Sadhan Samanta illegally posses and sells country spirit to publics.

Hence, I pray a cog case may kindly be started against accused namely Sadhan Samanta aged 56 yrs s/o Lt. Prahallad Samanta of Uttar Baguan, P.S. Tamluk, Dist-Purba Medinipur under proper section of law.
