Sir,  
In producing herewith 02 arrested accused persons namely 1) Najrul Khan age 28 S/O Alauddin Khan and 2) Nasir Khan age 25 S/O Alauddin Khan both of village Padumbasan ward no 12 PS Tamluk Dist Purba Medinipur along with seized vehicles/motorbikes 1) One KTM Motorbike bearing registration no WB 20AA/5311, Chassis no VBKJUC4M3CC00230 and Engine no. 2-9068\*02449\* 2) One KTM Motorbike having no registration no. Chassis no VBKJYJ4D3FC231254 and Engine no. 5-902\*24262\* 3) One Hero Honda Splender Motorbike having registration no. WB30K- 7998, Chassis no. MBLHAI0ADB9K01652 and engine no. HA10EHB9K00708 4) One vehicle of make Chevrolet Beat LS having registration no WB30J/7346, Chassis no MA6BFBC2BBT050457 and Engine no B12D110AJVZ110730019 5) One Tata Ace vehicle bearing registration no. WB/29A-8361, Chassis no. NAT445082EBF24960 and engine no. 2751D106FVYS56965 6) One Tata Ace vehicle bearing registration no WB 29A /0590, Chassis no. MAT4450519VE07704 and Engine no. 2751D105EQZS44893.

I S.I. Satya Charan Adhikary of Tamluk PS do hereby lodge a written complainant against above noted two arrested accused persons to the effect that on 12.04.2017 at 00.15 hrs while myself SI Satya Charan Adhikary along with C/1240 Sanjib Kr Das, C/1120 Sanjay Bhowmick and NVF Chandra Sekhar Bhowmick all of Tamluk PS were assisting SI Prasanta Banik and force of Mahishadal PS in conducting raid in the house of the above mention accused persons in C/W Mahisadal PS case no. 108/17 dated 6/4/17 U/S 365/379/120B IPC for recovery and arrest in connection with the said Mashidal PS case, I found the above mentioned motorbikes and vehicles in the premises of the house of these two accused persons. Finding these vehicles I asked the above mentioned two accused persons to produce registration certificates or any other paper of the said motorbikes and vehicles. But inspite of my repeated approach these two accused persons failed to produce any registration certificates or any other papers which would prove the ownership of the vehicles in their name. On interrogation initially they gave different statements in different times however on repeated asking they stated that the above stated three motorbikes and three vehicles have been obtained by them by theft from different places and they have accumulated these vehicles in their house premise for use. So it was believed that they receive and deal in stolen motorbikes and vehicles.

So I seized the above mentioned motorbikes and vehicles from their possession as found in their house premises under proper seizure list in between 00.20 hrs to 01.45 hrs on 12/4/17. The seizure list was duly signed by the witnesses 1) Suman Das S/O Gopal Chandra Das of Padumbasan of ward no. 12 PS Tamluk Dist Purba Medinipur and 2) Sumit Chakrobrotty S/O Ashish of do who were called to remain as witnesses during seizure. The seizure list was also signed by the accused persons. I also arrested them for receiving and dealing in stolen vehicles /motorbikes and for assisting in disposing stolen vehicles/motorbikes. I therefore pray that a cog case may kindly be started against the above noted accused persons under section 413/414 I.P.C.
