Sir,

In producing herewith arrested accused person namely Srimanta Bag aged 30 yrs s/o Biswajit Bag of Chandramerh, PO- Dhalhara, P.S. Tamluk, Dist- Purba Medinipur along with the seized articles (i) fifteen bottles of country spirit and each bottle containing 600 ml. and cost of Rs. 65/- per bottle under proper seizure list. I ASI Bishnupada Panda of Tamluk P.S. do hereby lodged complaint to the effect that on 19.04.2017 at 17.35 hrs. myself along with C/750 Jayanta Patra, C/1083 Jayanta Hansda & C/ 917 Prabir Das left P.S. to perform special raid duty vide Tamluk P.S. G.D.E. no. 1358 dated 19.04.2017 and C.C. no- 1545 dated 19.04.17. In course of special raid duty at Radhaballypur received information from my reliable source that one person seiling country sprit illegally at Chandramerh his grocery shop. We held raid at that place at 18.55 hrs Chandramerh as identified by my source and apprehended country spirit seller in presence of witnesses. Search was made at the place in presence of apprehended person, witnesses and police party and found (i) fifteen bottles of country spirit and each bottle containing 600 ml. and cost of Rs. 65/- per bottle kept in a nylon bag. Being asked the apprehended person disclosed his identity as Srimanta Bag aged 30 yrs s/o Biswajit Bag of Chandramerh, PO-Dhalhara, P.S. Tamluk, Dist- Purba Medinipur and on demand he fails to produce any valid license, papers, documents or challan for posses and sells country spirit to publics. I seized (i) fifteen bottles of country spirit and each bottle containing 600 ml. and cost of Rs. 65/- per bottle in a nylon bag after preparing proper seizure list duly signed by the witnesses and as well as the apprehended person. I took sample from seized article and labeled it also. I arrested the apprehend person Srimanta Bag issued memo of arrest and informed him ground of arrest. During local enquiry it is crystal clear that Srimanta Bag illegally posses and sells country spirit to publics. Hence, I pray a cog case may kindly be started against accused namely Srimanta Bag

aged 30 yrs s/o Biswajit Bag of Chandramerh, PO- Dhalhara, P.S. Tamluk, Dist-Purba Medinipur under proper section of law.
