In producing herewith arrested accused person namely Gobinda Das aged 29 yrs s/o Purnananda Das of village + P.O- Kurpai, P.S. Tamluk, Dist-Purba Medinipur along with the seized articles twenty two bottles of country spirit of Sun brand and each bottle containing 600 ml. and cost of Rs. 65/- per bottle under proper seizure list. I ASI Shib Charan Singh of Tamluk P.S. do hereby lodged complaint to the effect that on 22.04.2017 at 16.25 hrs. myself along with other officers and force C/1315 Amit Jana, C/1650 Abdul Rajjak & NVF Chandra Sekhar Bhowmik left P.S. to perform special raid duty vide Tamluk P.S. G.D.E. no. 1470 dated 21.04.2017 and C.C. no-1569 dated 21.04.17. In course of special raid duty at Radhamoni received information from my reliable source that one person selling country spirit illegally at Kurpai Bazar in his meet shop. We held raid at that place at 20.35 hrs Kurpai Bazar as identified by my source, apprehended country spirit seller in presence of witnesses. Search was made at the shop in presence of apprehended person, search his shop and found twenty two bottles of country spirit of Sun brand and each bottle containing 600 ml. and cost of Rs. 65/- per bottle. Being asked the apprehended person disclosed his identity as Gobinda Das aged 29 yrs s/o Purnananda Das of village + P.O- Kurpai, P.S. Tamluk, Dist- Purba Medinipur and on demand he fails to produce any valid license, papers, documents or challan for posses and sells country spirit to publics. I seized twenty two bottles of country spirit of sun brand and each bottle containing 600 ml. and cost of Rs. 65/- per bottle after preparing proper seizure list duly signed by the witnesses and as well as the apprehended person. I took sample from seized article and labeled it also. I arrested the apprehend person Gobinda Das after preparing proper memo of arrest and informed him ground of arrest. During local enquiry it is crystal clear that Gobinda Das illegally posses and sells country spirit to publics from his meet shop.

Hence, I pray a cog case may kindly be started against accused namely Gobinda Das aged 29 yrs s/o Purnananda Das of village + P.O- Kurpai, P.S. Tamluk, Dist- Purba Medinipur under proper section of law.
