In producing herewith arrested accused person namely Sanatan Routh aged 45 yrs s/o Lt. Akul Routh of Bahichard, P.S. Tamluk, Dist- Purba Medinipur along with the seized articles (i) Ten bottles of country spirit and each bottle containing 600 ml. and cost of Rs. 65/- per bottle under proper seizure list. I ASI Bishnupada Panda of Tamluk P.S. do hereby lodged complaint to the effect that on 17.05.2017 at 18.45 hrs. myself along with C/500 Brambhananda Panda, C/448 Ashis Ray, C/1329 Sunil Barman left P.S. to perform special raid duty vide Tamluk P.S. G.D.E. no. 977 dated 17.05.2017 and C.C. no 1927 dated 17.05.17. In course of special raid duty at Nimtouri received information from my reliable source that one person selling country sprit illegally at Radhamoni Bazar from his shop. Than my self along with force had been village Radhamoni at about 20:05 hrs .I contacted with two passersby namely (i) Ashis Singha s/o Laxman Chandra Singha of Joyrambati, PS- Tamluk and (ii) Sanatan Manna s/o Lt. Pashupati Manna of Barbaria, PS- Tamluk both of Dist - Purba Medinipur and request them to assist police and they agreed. We held raid at that shop as identified by my source and apprehended the country spirit seller in presence of witnesses as noted above. Search was made at the shop in presence of apprehended person, above noted witnesses and police party and found (i) Ten bottles of country spirit and each bottle containing 600 ml. and cost of Rs. 65/- per bottle kept in a nylon bag. Being asked the apprehended person disclosed his identity as Sanatan Routh aged 45 yrs s/o Lt. Akul Routh of Bahichard, P.S. Tamluk, Dist- Purba Medinipur and on demand he fails to produce any valid license, papers, documents or challan for posses and sells country spirit to publics. I seized (i) Ten bottles of country spirit and each bottle containing 600 ml. and cost of Rs. 65/- per bottle kept in a nylon bag after preparing proper seizure list duly signed by the above noted witnesses and as well as the apprehended person. I took sample from seized article and labeled it also. I arrested the apprehend person Sanatan Routh, issued memo of arrest and informed him ground of arrest. During local enquiry it is crystal clear that Sanatan Routh illegally posses and sells country spirit to publics. Hence, I pray a cog case may kindly be started against accused namely Sanatan Routh aged 45 yrs s/o Lt. Akul Routh of Bahichard, P.S. Tamluk, Dist- Purba Medinipur under proper section of law.
