Dear Sir,

I do hereby lodged complaint empowered by the electricity act 2003 read with amendment act 2007 to the effect that, Sri Kusadhvaj Manik S/O Lt. Debendranath Manik, Vill -Bar Harasankar, PS - Tamluk, Dist Purba Medinipur has committed an offence under section 135 electricity act read with amendment act 2007 which stated here under.

On 23/05/2017 at about 1:40 pm I Sri Dipankar Bairagi along with Sri Sushovan Maji SAE(E) Matangini CCC and Sri Sukdev Sahoo HG-SR-LM Matangini CCC with other officials entered to the domestic premises of Sri Kusadhvaj Manik S/O Lt. Debendranath Manik, Vill -Bar Harasankar, PS - Tamluk, Dist Purba Medinipur and during inspection it was found that Sri Kusadhvaj Manik was consuming electricity dishonestly by way of direct hooking from nearest L1 mains unauthorizely, at the tune of load 0.588 KVA causing loss of revenue to WBSEDCL.

As theft of Electricity was detected during inspection, the service connection was disconnected with removal of unauthorized hooking wire and thereafter some portion of hooking wire Double core flexible wire Black color 3 mtr. Approximate with hooking device was seized under memo of seizure list in presence of witnesses and duly signed by the witnesses on it. The above seized article was duly packed and labeled at the inspection site and signature of the witnesses also obtained on the packet and label but the consumer refused to sign on seizure list and labeled. I also prepared an inspection report at site with duly signed by them on it. After completion of inspection the inspection team left the aforesaid premises at 2:00 pm.

Thus the accused Sri Kusadhvaj Manik S/O Lt. Debendranath Manik, Vill -Bar Harasankar, PS Tamluk, Dist Purba Medinipur has committed an offence u/s 135(i) (a) of the electricity act 2003 read with amendment act 2007 for commission of theft in respect of power unauthorizely.

So you are requested to take cognizance of this complain and treat it as FIR.
