Sir,

I ASI Sankar Mondal of Tamluk PS do here by lodged a complaint to the effect that today (03.06.17) myself along with constable 750/Joyanta Patra and lady constable 1740/Sudesna Sanki left PS to perform evening mobile duty at 14.35 hrs. vide Tamluk PS GDE Entry No. 134 dt. 03.06.17 and CC No. 2129 dt. 03.06.17. In course of mobile duty I got information from my source that from 30.05.17 to 01.06.17 microphone/sound system were used in high volume in the late hours of night. On getting such information I along with forces had been village of Bhubaneswarpur and primarily enquired into the above noted matter. On primary enquiry it is came to light that a local club in the name and style as Baba Loknath Sangha of village Bhubaneswarpur under PS Tamluk organized a puja of god Narayana. The members of the said club were playing sound system/microphones etc. for the purpose of said puja in high volume in the late hours of night from 30.05.17 to 01.06.17 without permission from competent authority.

Under the above I pray that a cog case may kindly be started against the members of the Baba Loknath Sangha club of Bhubaneswarpur village under Tamluk PS, Dist - Purba Medinipur under proper section of law.
