Sir,

I ASI Nanda Dulal Mahakul of Tamluk PS do hereby lodge complaint to the effect that on 05.06.2017 at 14.35 hrs, myself along with force left PS for mobile duty vide Tamluk PS GDE No 247 date 05.06.2017 and CC No 2163/17 dated 05.06.2017 During mobile duty received information from duty officer ASI Amitava Mondal that a person has been detained at Gourangapur Sporting Association at Gourangapur village on suspicion of thief and he is being assaulted. So, as per order O/C Tamluk PS myself along with accompanied force went to the said Club. But on reaching there no such person was found to be detained in the Club. On enquiry it was known that today (05.06.17) around 12.00 hrs a person was detained in nearby village hut on suspicion of thief he was brought to the Club there he was detained and assaulted by some members of Club and local inhabitant of Gourangapur and nearby village and after that said person allowed to go away from the club. In this regard a video footage/clip was also found in cell phone of different publics and where it is seen that a person of aged about 18 years having bleeding injury in his hand is detained by some person in the said club room and is being humiliated. However none of the people available and around in the said place was able to identify the said humiliated person.

I therefore pray that a cog case may kindly be started against the club members of GSA Club at Gourangapur and some local inhabitants who were involved in detaining, assault and humiliated of the said unknown person.
