Sir,

I ASI Nanda Dulal Mahakul of Tamluk PS do hereby lodge complaint to the effect that on 05.06.2017 at 14.35 hrs, myself along with force left PS for mobile duty vide Tamluk PS GDE No 247 date 05.06.2017 and CC No 2163/17 dated 05.06.2017. During mobile duty received information from duty officer ASI Amitava Mondal that some person where blocked NH 41 at Kakgechia. After receiving such information I along with forces reached at Kakgechia bus stand on NH 41 on 05.06.17 at 19.25 hrs and found that around 150/200 unknown persons had resorted to road blocked on the National Highway at Kakgechia Bus Stand. They blocked the road as part of their agitation against the activities of club members of GSA Club of village Gourangapur, PS Tamluk, Dist - Purba Medinipur. Police resorted them to withdraw the blocked and after a prolonged persuasion finally the road blocked was withdrawn on 05.06.17 at 21.30 hrs.

Due to road blocked a large number of traffic were stranded on flaks of road carrying obstruction to the public.

Under the above circumstances, I pray that a cog case may kindly be started against the 150/200 unknown accused persons and obliged.
