Dear Sir,

I do hereby lodged complaint empowered by the electricity act 2003 read with amendment act 2007 to the effect that, Sri Radheshyam Ghora S/O Lt. Prafulla Ghora, Vill –Pashara, PS – Tamluk, Dist Purba Medinipur has committed an offence under section 135 electricity act read with amendment act 2007 which stated here under.

On 07/06/2017 at about 1:50 pm I Sri Dibyendu Sekhar Bhunia along with Sri J S Neogi SO (S&LP), PMRO, Sri Dipankar Bairagi AE & SM, Matangini CCC , and Sri Madhab Manna, LM, PMRO and Sri Sukdeb Sahoo, Hg Sr LM, Matangini CCC with other officials entered to the domestic premises of Sri Radheshyam Ghora S/O Lt. Prafulla Ghora, Vill –Pashara, PS – Tamluk, Dist Purba Medinipur vide Con\_ID:222122709 and Meter no:G012837 and during inspection it was found that Sri Radheshyam Ghora was consuming electricity dishonestly by way of direct hooking from nearest LT mains unauthorizely, at the tune of load 1 KW causing loss of revenue to WBSEDCL for bypassing the meter for less recording of energy meter.

As theft of Electricity was detected during inspection, the service connection was disconnected with removal of unauthorized hooking wire and thereafter some portion of hooking wire single core flexible wire black color 3 meter approximate with hooking device was seized under memo of seizure list in presence of witnesses and duly signed by the witnesses on it. The above seized article was duly packed and labeled at the inspection site and signature of the witnesses also obtained on the packet and label but the consumer/representative refused to sign on seizure list and label. I also prepared an inspection report at site duly signed by them on it. After completion of inspection the inspection team left the aforesaid premises at 2:10 pm.

During our raid, the two sons of Sri Radheshyam Ghora and other inmates obstructed us to discharge our bonafide officials duty, however we managed to perform our duty. They also abused us in filthy languages and threaten us to implicate us in false cases.

Thus the accused Sri Radheshyam Ghora S/O Lt. Prafulla Ghora, Vill –Pashara, PS – Tamluk, Dist Purba Medinipur has committed an offence u/s, 135(i) (b) of the electricity act 2003 read with amendment act 2007 for commission of theft in respect of power unauthorizely and the two sons have violated the provision of IPC .

So you are requested to take cognizance of this complain and treat it as FIR.
