Dear Sir,

I, do hereby lodged a written complaint empowered by enabling the Electricity Act 2003 (with Amendment Act 2007) against one Gouranga Pradhan, S/O- Lt. Haripada Pradhan, Vill.-Nikashi Bazar, P.S-Tamluk, Dist-Purba Medinipur for commission of theft in respect of electricity u/s 135 (1)/ (b) of Electricity Act 2003 with Amendment Act 2007 which stated here under.

Today i.e. 19/06/2017 at about 12:35 p.m., I Sri Siddhartha Samanta, Assistant Engineer and Station Manager of Tamluk CCC, WBSEDCL along with Sri Swarup Kumar Samanta, SAE(E), Tamluk CCC and Sri Dibyendu Sekhar Bhunia, DE(S&LP), Regional Office, and Sri Madhab Ch. Manna, LM, Regional Office, Purba Medinipur and other officials had been to the Commercial premises of Gouranga Pradhan, S/O- Lt. Haripada Pradhan, Vill.-Nikashi Bazar, P.S-Tamluk, Dist-Purba Medinipur for inspection purpose. In course of inspection it was found that Gouranga Pradhan has got one meter reference meter no.-L4225999 and con id.-201536714, instead of that he was consuming electricity unauthorisedly by way of direct hooking from nearest LT mains for lees recording of energy to energy meter to run his commercial business for his wrongfull gain, causing loss of revenue of WBSEDCL at the tune of load 0.4 KW

As theft of Electricity was detected during inspection, at first I disconnected the service connection with removal of unauthorized hooking wire from LT mains and there after I seized some portion of hooking wire single core flexible wire blue and red colour with hooking device 5mtr. Approx and one switch board make pretty with socket in the presence of withnesses and duly signed on it by the witnesses alongwith the sign of the alleged representative smt. Sikha Pradhan W/O- Gouranga Pradhan. The above seized article, which was utilized for theft i.r.o power. The seized article was duly packed and labeled at the inspection site in presence of the witnesses and their signature was duly obtained on the packet and labeled. I also prepared an inspection report at site and duly signed by the witnesses and the alleged representative smt. Sikha Pradhan W/O- Gouranga Pradhan. After completion of inspection, the team left the aforesaid premises at 12:55 p.m.

Thus the accused Gouranga Pradhan, S/O- Lt. Haripada Pradhan, Vill.-Nikashi Bazar, P.S-Tamluk, Dist-Purba Medinipur has committed an offence u/s 135 (1) (b) of Electricity Act 2003 (with Amendment Act 2007) for commission of theft in respect of electricity dishonestly.

Under the above circumstances you are requested to take the cognizance of the case and treat the same as FIR. The FIR is typed by me.
