Sub- Lodging of complaint against authority of "Tamaralipta Technical College".

In producing herewith arrested accd Gopal Bera aged about 27 yrs s/o Buddhadeb Bera of village Kapasberia, P.O.-Ganjanarayanpur, P.S.-Tamluk, Dist. Purba Medinipur alongwith seized following documents :-

1. One Memorandum of Association vide Deed No. S/2L/17809 dt 28.10.14 in the name of Tamaralipta Technical Society located at Tamluk near Ganjanarayanpur.
2. One Khata containing details of students admitted in different sessions of Tamaralipta Technical College.
3. One Certificate of Registration vide no S/2L/17809 in the name of Tamaralipta Technical Society .
4. One Certificate of Enlistment vide no. 200812017010184 and Enlistment no. 200811264 in the name of Tamaralipta Technical College issued by Tamaralipta Municipality for the session 2017-18.
5. List of members of Executive Committee of Tamaralipta Technical College for the year 2016-17 in which name of Nasimuddin Ahmed of Hallyan PS Bagnan, Dist Howrah as president and Gopal Bera of Kapasberia PS Tamluk as Secretary of the committee and 7 others are mentioned.
6. One teacher's Attendance Register of Tamaralipta Technical College.
7. One Register of admitted students in Electrical ITI trade of Tamaralipta Technical College

and I beg to report that today on 23.06.17 at about 13.45 hrs on receipt of an information of running of a fake Institution styled as Tamaralipta Technical College from Sri S K Pramanik, Director of Industrial Training, Govt of west Bengal, Karigari Bhawan, 2nd floor, Action Area III, Rajarhat- New Town, Kol-160, I informed the matter to my superior and as per direction left PS with officers and force of Tamluk PS and officers of DEB, Purba Medinipur for Nimtala More, Tamluk to work out information of running of a fake Institution styled as Tamaralipta Technical College vide GDE no. 1273 dt 23.06.17. At about 14.05 hrs we reached at Nimtala More and identified the institution namely Tamaralipta Technical College located at Sankarara, ward No 15 under PS Tamluk. The said institution was found opened and we accompanied with two local witnesses namely i. Manoj Kr Halder (46 yrs) s/o Lt Asok Kr Halder of village Salgachhia, ward No 17, PS Tamluk and ii. Dulal Singha (41 yrs) s/o Lt Gourhari Singha of Dakshin Chara Sankarara, Ward No 18, PS Tamluk entered into the office of Tamaralipta Technical College located in the 3rd floor of the building of one Sahadeb Mondal and found the person Gopal Bera in the chair of the Admission cum Office Room of the institution. We disclosed our identity and stated purpose of our visit. We then asked him to produce the necessary relevant documents in support of his advertisement in which it is claimed as ITI being affiliated to NCVT(Govt of India, New Delhi). But he failed to produce the same and admitted that he has no such affiliation either from NCVT or from State Council of Vocational Training and he alongwith other members of the Executive Committee of the institution hatched criminal conspiracy and

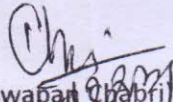
and misappropriated money by means of forgery and cheating by admitting students on false promise by taking money of Rs 50,000/- or more from each candidate.

I conducted search into the office of Tamaralipta Technical College in presence of said independent two witnesses and seized the above incriminating documents as produced by the accd Gopal Bera. The seizure was made today on 23.06.17 in between 14.35 hrs to 15.15 hrs observing all legal formalities duly signed by the witnesses, a copy of seizure list is handed over to him obtaining his signature on it.

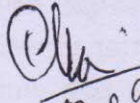
Thus, the accd Gopal Bera violated the provisions of Law and liable to be prosecuted u/s 120 B/ 420/406/ 465/468 IPC for running such fake institution without any affiliation from the proper forum. So, the accd Gopal Bera has been arrested from his office on 23.06.17 at 15.20 hrs after informing him the ground of arrest. I have supplied a copy of memo of arrest to him. He made no complaint of any ill treatment from any corner.

So, you are requested to start a case u/s 120B/ 420/406/ 465/468 IPC against the arrested accd Gopal Bera and others members of the executive Committee of the college namely Tamaralipta Technical College. The seized documents as stated above may please be acknowledged.
