Sir,

In producing herewith arrested accused person namely Ananta Mal @ Lala Mal (60 Yrs) s/o- Lt. Goshto Mal of Nilkuntha, P.S - Tamluk, District- Purba Medinipur along with the seized articles seven bottles country spirit and each bottle containing 600 ml. under proper seizure list. I ASI Nandadadual Mahakul of Tamluk P.S. do hereby lodged complaint to the effect that on 27.06.2017 at 17.35 hrs. myself along with other officers and C/144 Sankar Sahoo, C/1120 Sanjoy Bhowmik, C/1329 Sunil Barman left P.S. for holding special raid duty at P.S. area vide Tamluk P.S. G.D.E. no. 1479 dated 27/06/2017 and C.C. no 2522 dated 27/06/17. In course of special raid duty at Naikuri received information from my reliable source that one person selling country spirit to public illegally at Nilkuntha from his temporary shop. We reached at Nilkuntha 20.55 hrs and found Ananta Mal @ Lala Mal selling country spirit to public. Held raid at the said temporary shop of Ananta Mal. Search was made at the temporary shop in presence of witnesses and police party and seized seven bottles country spirit from the possession of Aananta Mal. Being asked he disclosed his identity as Ananta Mal @ Lala Mal (60 Yrs) s/o- Lt. Goshto Mal of Nilkuntha, P.S - Tamluk, District- Purba Medinipur and on demand he fails to produce any valid license, papers, documents or challan for posses and sells country spirit to publics. I seized seven bottles country spirit and each bottle containing 600 ml. after preparing proper seizure list duly signed by the witnesses. I took sample from seized article and labeled it also. I arrested the apprehend person Ananta Mal @ Lala Mal, issued memo of arrest and informed him ground of arrest. During local enquiry it is crystal clear that Ananta Mal @ Lala Mal illegally posses and sells country spirit to publics.

Hence, I pray a cog case may kindly be started against accused namely Ananta Mal @ Lala Mal (60 Yrs) s/o- Lt. Goshto Mal of Nilkuntha, P.S - Tamluk, District- Purba Medinipur under proper section of law.
