I do hereby lodge complaint empowered by the Electricity Act, 2003 to the effect that Sri Bikash Barman, S/O- Bhujahari Barman, Village- Tula, P.O. Haridaspur, PS- Tamluk, Dist- Purba Medinipur has committed theft of electricity U/S 135 of the E. Act, 2003 read with Amendment Act, 2007 as stated here under:

On 17.01.2017 at about 12:30 pm, I Sri Uttiya Roy Chowdhury, AE & SM Gourangapur Customer Care Centre along with (i) Sri Samit Hazra, Hg. Sr. T.M. Gourangapur C.C.C. (ii) Sri Prasanta Mahapatra, Hg. TSH, Gourangapur C.C.C. went to the Agriculture (Rural) premises of Bikash Barman, S/O- Bhujahari Barman, Village- Tula, P.O. Haridaspur PS- Tamluk, Dist- Purba Medinipur and found that he was consuming electricity dishonestly by way of direct hooking from the nearest L.T.O.H. mains of WBSEDCL. As theft of electricity was detected during the inspection some portion of PVC Alm. wire with hooking device was seized in presence of the witnesses and their signatures obtain on the seizure list. The seized article are duly packed, sealed & labeled at the inspection site and signatures of the witnesses obtain on the sealing label.

The inspection team left the aforesaid premises on 17.01.2017 at about 12:50 pm. Thus the Bikash Barman, S/O- Bhujahari Barman, Village- Tula, P.O. Haridaspur, PS- Tamluk Dist- Purba Medinipur has committed an offence U/S 135(i) (a) of E. Act, 2003 read with Amendment Act, 2007.
