Sir,

I S.I. Samir Kumar Aich of Tamluk PS submitted a written complainant against Arun Dey of Nikashi,, P.S. Tamluk, District Purba medinipur and one unknown stacking building materials and other articles (Bricks, sand, stone chip, bolders, wood etc) from Nikashi bazaar to Srirampur bridge by the side of the state Highway obstructing the potion public way rashly and negligently as to on danger human life as the personal safety of the public. The fact of the case in brief is that today i.e. 18.01.2017 at 11.15 hrs. myself along with C/1329, Sunil Barman, C/ 16 Samar Pramanik , LC 1822, Sagarika Singha and LC 1811 Sabita Mandal , vide Tamluk P.S. GDE No- 889 dated 18.01.2017 and CC No 242/17 dated 18.01.2017 were performing special duty over P.S. area for removal of unwanted construction material from Govt land and found that some persons were doing their business of supplying building materials and fine wood keeping the materials at both side of the state High way from at Nikashi bazaar to Srirampur bridge obstructing the public way and as a result the road was becoming narrower which became dangerous for the public safety on the road. Considering the dangerous of the safety as per instruction of SP, Purba Medinipur awareness and making was done on 11.01.2017 to remove the same by the respective party. But they did not remove the same. Accordingly police arrangement was done The Sub Divisional Officer Tamluk had also passed order for magisterial duty for the said removal vide his memo no 40/Genl (1)/13 Dt. 11.01.2017. Accordingly today was fixed for removal of the materials from the both side of state High way from at Nikashi bazaar to Srirampur bridge.

At 14.05 hrs myself with force and officer reach at Nikashi bazar and started miking for removal of building materials and fire woods etc which were kept at both side of State High way. We also took photograph of the stacking of such materials dangerously. On local enquiry it is learnt that some unknown persons had stack materials at the side of State Highway. And others who were not found at spot during removal process.


As per order of Ld. Magistrate on duty we remove the materials from the both side of the road and keep them apart as it was impossible to seize a huge quantity of materials and keep than at PS compound. The PWD authority had provided man power and JCB for the removal work.

From the circumstances the unknown persons who had stacked the building materials fine woods and others materials at both side of the road from Nikashi bazaar to Srirampur bridge who had voluntarily stacked the building materials at the both side of road of state High way from at Nikashi bazaar to Srirampur bridge obstructing the potion public way rashly and negligently as to on danger human life as the personal safety of the public had committed offence U/S 283/336 IPC.

Hence, I pray a cog case may kindly be started against Arun Dey of Nikashi,, P.S. Tamluk, District Purba medinipur and one unknown person U/S 283/336 IPC and arrange for its investigation.
