I do hereby lodged complaint empowered by the electricity act 2003 read with amendment act 2007 to the effect that, Sri Madhusudan Manna S/O TaraniManna, Vill -Uttar Osudpur, PS - Tamluk, Dist Purba Medinipur has committed an offence under section 135 electricity act read with amendment act 2007 which stated here under.

On 19/01/2017 at about 1:40 pm I Sri Dipankar Bairagi along with , Sri Sukumar Bera HG-SR-LM Matangini CCC and Sri Ajay Kumar Manna with other officials entered to the domestic premises of Sri Madhusudan Manna S/O TaraniManna, Vill -Uttar Osudpur, PS - Tamluk, Dist Purba Medinipur vide con\_id:200199335 and Meter no:P1341197 and during inspection it was found that Sri Madhusudan Manna was consuming electricity dishonestly by way of direct hooking from nearest LT mains unauthorizedly, at the tune of load 1 KVA causing loss of revenue to WBSEDCL for bypassing the meter for less recording of energy meter.

As theft of Electricity was detected during inspection, the service connection was disconnected with removal of an authorized hooking wire and thereafter some portion of hooking wire single core flexible wire blue color 3 mtr, Approximate with hooking device and one yellow card (Sl no: 367320) was seized under memo of seizure list in presence of witnesses and duly signed by the witnesses on it. The above seized article was duly packed and labeled at the inspection site and signature of the witnesses also obtained on the packet and label but the consumer/representative refused to sign on seizure list and labeled. I also prepared an inspection report at site with duly signed by them on it. After completion of inspection the inspection team left the aforesaid premises at 2:00 pm.

Thus the accused Sri Madhusudan Manna S/O TaraniManna, Vill -Uttar Osudpur, PS - Tamluk, Dist Purba Medinipur has committed an offence u/s 135(i) (b) of the electricity act 2003 read with amendment act 2007 for commission of theft in respect of power unauthorizedly.

So you are requested to take cognizance of this complain and treat it as FIR.
