Sir,

I ASI Amitava Mondal of Tamluk PS hereby lodge written complaint against 30/35 unknown persons to the effect that today i.e. 26.01.17 at morning myself along with C/550, Akshay Kumar Dolai and C/1141, Bharat Chandra Ghosh all of Tamluk P.S were performing morning mobile duty over PS area vide Tamluk PS GDE No. 1306 Dt. 26.01.17 and C.C No. 351/17 dt. 26.01.17. In course of morning mobile duty received information over telephone from duty Officer of Tamluk PS at about 11.30 hrs that 30/35 unknown persons had resorted to road blocked on Tamluk Panskura state high way at Kumarganj Bus stand.

On receipt this information myself along with force reached at Kumarganj Bus stoppage and found that around 30/35 unknown persons had resorted to road blocked on the state Highway at Kumarganj Bus Stoppage. They blocked the road as part of their agitation against government policies. Force resorted them to withdraw the blocked and after a prolonged persuasion finally the road blocked was withdrawn on 26.01.17 at 12.25 hrs.

Due to road blocked a large number of traffic were stranded on flanks of road carrying obstruction to the public.

under the above circumstances, I pray that a case U/S 283/341 IPC read with section 18 of the West Bengal High way Act 1964 may kindly be started against the 30/35 unknown accused persons and obliged.
