Memory Card & Pandrive etc for commercial gain, at a Mobile shops (i) styled as " NAYEK MOBILE & REPIARING CENTRE" situated at Ramtarak Hat , P.S. – Tamluk , Dist.- Purba Medinipur owned by Debabrato Majhi (24 yrs) S/O L.Nimai Majhi of , Ramtarak Hat , P.S. – Tamluk , Dist.- Purba Medinipur detected on 29/12/2016 at morning.

In violation of the provisions of u/s 52A the copyright Act, 1957 as amended up to date. the above downloading audio/Video songs, movies , etc for which the above unscrupulous person by such unlawful activities is earning money illegally for wrongful gain of them and causing wrongful loss to the Government and to the above music company and thus committing offences, which are punishable U/S 63/65/68A under the copyright Act.
