Sir,

In producing herewith arrested accused person namely Kamalendu Manna (Aged about 30 Yrs) S/O- Lt. Chandi Charan Manna of Hogalberia, P.S. Tamluk, District Purba Medinipur along with the seized articles as per seizure list. I have submitted a written complainant against him to the effect that on 06.02.2017 at 13.05 hrs. myself along with C/448, Ashis Roy, C/767, Bangshi Prasad Rana, LC/1739, Anju Moni Barman were performing evening mobile duty over P.S. area vide Tamluk P.S. GDE No- 334 dated 06.02.2017. In course of evening mobile duty received information from a reliable source regarding selling illegal I/D liquor by the above noted accused person at Hogalberia from his hotel (Srikrishna Hotal) under Tamluk P.S. I immediately informed the matter to O/C Tamluk PS over Telephone, and as per instruction of O/C Tamluk P.S. left for Hogalberia to work out the information.

Myself along with force while reached at Hogalberia at 17.05 hrs and we stopped our vehicle in front the door of the hotel of above noted person. But in short time, getting sound of police jeep, some unknown persons who were probably buying liquor from the above noted person managed to flee away, however, we managed to intercept the above noted person and given my identity and stating about the information, we asked some local people to accompany us and they agreed. During search following amount of I/D liquor, has been found from his hotel. On being asked he failed to produce any license / Papers/ Challan for keeping / selling such quantity of I/D liquor. Then I seized 07 (Seven) Ltrs. I/D liquor which was loaded in a plastic Jarycane and 09 bottles country sprit (Sun) each 600ml, after preparing proper seizure list duly signed by the local witnesses and as well as the accused person. Then I extracted one ltrs I/D liquor from the above noted seized article as test sample. Then the seized articles were labeled and arrest the above noted accused person after preparing proper memo of Arrest.

Hence, I pray a cog case may kindly be started against the accused namely Kamalendu Manna (Aged about 30 Yrs) S/O- Lt. Chandi Charan Manna of Hogalberia, P.S. Tamluk, District Purba Medinipur under proper section of law.
