Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Basudeb Das, S/O - Lt Narayan ch. Das, permanent resident of Vill- Mansinghaber, P.O -Pankhai, P.S -Talpatighat Coastal, Dist Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 08.02.2017 at about 12:30 PM I, Sri Manas Maity, AE(U), (S&LP), Contai Division along with Sri Pradip Kr. Chakraborty, SO (S&LP), Contai Division Office, Sri Haripada Das Grl T.S.H. & Sagar Kandar LM, Khejuri CCC and others had been to the village Mansinghaber for routine inspection purpose. During inspection it was found that S Basudeb Das was consuming electricity dishonestly in his Agricultural (STW) premise unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL inspite having one service connection against Con Id- 201962814, which was previous disconnected on 03.02.2017 due to remaining outstanding dues amount Rs. 6845/- and causing considerable loss of revenue of WBSEDCL to the tune of load 4.38 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 3 (three) nos of separated single core 10 Sq mm 1 (one) red and other 2 (two) nos. yellow colour PV coated aluminium conductor of length 2 (two) meter each approx along with hooking device used to run the agricultural pump-meter unauthorisedly for agricultural purpose were seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Basudeb Das acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled the inspection site and signature of the WBSEDCL representative has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises about 01:00 PM.

Thus the accused Sri Basudeb Das, S/O - Lt Narayan Ch. Das, Vill - Mansinghab P.O -Pankhai, P.S -Talpatighat, Dist- Purba Medinipur have committed an offence u/s 1 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
