Dear Sir,

I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sk Motiur Rahman , S/O- Faijul Islam, of Vill-Alichak , P.O-Nijkasba, P.S-TalpatiGhat Coastal, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 07.06.2017 at about 2.00 PM, I Prashanta Biswal, AE & SM, Khejuri CCC along with Gokul Chandra Mandal HgSrLM, and Sk. Saddam Hossain TSH, Khejuri CCC and others had been to the Vill-Alichak, P.S- TalpatiGhat Coastal for routine inspection purpose. At first we went to the Commercial premises (Fishery) of Sk Motiur Rahman , S/O- Faijul Islam of Vill-Alichak, P.O-Nijkasba, P.S-TalpatiGhat Coastal, Dist-Purba Medinipur and during inspection it was found that Sk Motiur Rahman , S/O- Faijul Islam, consuming electricity unauthorisedly by the way of direct hooking from nearest LTOH Line of WBSEDCL causing loss of revenue to WBSEDCL at the tune of load 0.70 KVA.

As theft of electricity was detected during the inspection some portion of two core black coloured PVC coated 6 sq mm hooking cable of length 3 (three) meters (approx) along with Hooking Device were seized under memo of seizure list in presence of witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of witnesses and signatures of witnesses obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 2:20 PM.

Thus Sk Motiur Rahman , S/O- Faijul Islam of Vill-Alichak , P.O-Nijkasba, P.S-TalpatiGhat Coastal, Dist-Purba Medinipur has committed an offence u/s 135 (i)(a) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain & treat it as FIR.
