Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act, 2003 to the effect that Sri Kanak Barman, S/O- Lt. Anil Barman, Village- Rajnagar, P.O. Rajnagar Baharjola, PS- Tamluk, Dist- Purba Medinipur has committed theft of electricity U/S 135 of the E. Act, 2003 read with Amendment Act, 2007 as stated here under.

On 08.12.2016 at about 11:00 am, I Sri Uttiya Roy Chowdhury, AE & SM, Gourangapur Customer Care Centre along with (i) Sri Kshudiram Mahapatra, L.M, Gourangapur C.C.C. (ii) Sri Swapan Kr. Mahapatra, I.L.G. TSEI, Gourangapur C.C.C. went to the Domestic premises of Sri Kanak Barman, S/O- Lt. Anil Barman, Village- Rajnagar, P.O. Rajnagar Baharjola, PS- Tamluk, Dist- Purba Medinipur and found that he was consuming electricity dishonestly by making a bye-passing arrangement of the W.B.S.E.D.C.L.'s energy meter against Con ID- 200166846 for less recording of energy consumption in the energy meter. As theft of electricity was detected during the inspection some portion of PVC Cu wire (bye-passing arrangement) was seized in presence of the witnesses and their signatures obtain on the seizer list. The seized article are duly packed, sealed & labeled at the inspection site and signatures of the witnesses obtain on the sealing label.

The inspection team left the aforesaid premises on 08.12.2016 at about 11:20 am after disconnection the service line.

Thus the Sri Kanak Barman, S/O- Lt. Anil Barman, Village- Rajnagar, P.O. Rajnagar Baharjola, PS- Tamluk, Dist- Purba Medinipur has committed an offence U/S 135(f) (b) of E. Act, 2003 read with Amendment Act, 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R.
