Sir,

In producing herewith one arrested accused person namely Manik Samanta (40 Years) S/O Murari Samanta of Vill. Nilkuntha, PS. Tamluk, Dist. Purba Medinipur and following seized articles I, ASI Tapan Kr. Maji of Tamluk PS lodged a written complaint against Manik Samanta (40 Years) S/O Murari Samanta of Vill. Nilkuntha, PS. Tamluk, Dist. Purba Medinipur to the effect that today (10.12.16.) at 11.35 hrs. while myself along with C/1083 Jayanta Hansda and NVF Joydev Jana was engaged mobile duty vide Tamluk PS G.D.E No. 477/16 dt. 10.12.16 and C.C No. 5097/16 dt. 10.12.16, I received a source information that Manik Samanta was selling illegal I/D liquor in his Hotel Tarama Hotel at Milannagar village under Tamluk PS. Then I informed it to my O.C, Tamluk PS and as per his instruction I along with forces rushed to milannagar village & held raid & found that the said person was selling I/D liquor in his hotel at said village under Tamluk PS. On seeing Police party customers were fled away. Then I detained the above noted person who was selling I/D liquor. Then I contracted with the local people and requested them to accompany us for conducting search of said hotel. They also agreed with my proposal. Then searched was conducted in presence of witnesses found 10 (ten) Ltrs. I/D liquor in a white plastic Jar cane from his hotel, Then I have seized 10 (ten) Ltrs of I/D liquor in a plastic jar cane in presence of witnesses after preparing proper seizure list and labeled the same. I also extracted one ( 01 ) ltrs. I/D liquor in a bottle from seized article as test sample. Then i arrested the above noted accused person under proper memo of arrest.

Hence, I pray before your kind honour that a cog case may kindly be started against Manik Samanta (40 Years) S/O Murari Samanta of Vill. Nilkuntha, PS. Tamluk, Dist. Purba Medinipur under proper section of law and oblige.
