Sir,
In producing herewith arrested accused person namely Shyamsundar Adhikary (aged 42 Yrs) S/O- Trivanga Adhikary of village- Kamarbarh, PS- Tamluk, District- Purba Medinipur along with the seized articles as per seizure list. I have submitted a written complainant against him to the effect that today i.e. on 23.12.2016 at 13.15 hrs. myself along with C/750 Jayanta Patra, C/1315, Amit Kumar Jana vide Tamluk P.S. GDE No- 1145 dated 23.12.2016 and C.C. No 6224 dated 23.12.2016 and Tamluk P.S. were performing evening mobile duty over P.S. area. In course of mobile duty at about 19.35 hrs. received an information from my reliable source regarding selling illegal I/D liquor by the above noted accused person in a Dhaba at Kamarbarh beside NH 41 under Tamluk P.S. I immediately informed the matter to O/C Tamluk PS over Telephone, and as per instruction of O/C Tamluk P.S. left for Kumarganj to work out the information.

Myself along with force reached at kamarbarh at 19.55 hrs and we stopped our vehicle in front of the dhaba of the above noted person at Kamarbarh, but in short time, getting sound of police jeep, some unknown persons who were probably buying liquor from the above noted accused managed to flee away, however, we managed to intercept the above noted person and giving my identity and stating about the information, we asked some local people to accompany us and they agreed. During search following amount of I/D liquor has been found from his dhaba. On being asked he failed to produce any license /Papers/ Challan for keeping /selling such quantity of I/D liquor. Then I seized approx 05 (five) Ltrs I/D liquor which was loaded in a plastic jaricane after preparing proper seizure list duly signed by the local witnesses and the accused person. Then I extracted one Ltr. I/D liquor from the above noted seized article as test sample. Then the seized article was labeled and arrest the above noted accused person after preparing proper memo of Arrest.

Hence, I pray a cog case may kindly be started against the accused Shyamsundar Adhikary (aged 42 Yrs) S/O- Trivanga Adhikary of village- Kamarbarh, PS- Tamluk, District- Purba Medinipur under proper section of law.
