In producing herewith six (06) arrested accused persons named (i) Debendranath Manna (aged 45 yrs) S/O Lt. Chandicharan Mahna of village Garkilla, PS-Tamluk, Purba Medinipur, (ii) Pranabesh Jana (Aged 42 Yrs) S/O Krishnapada Jana of village Bahiragarh, P.S. Tamluk, District Purba Medinipur (iii) Sanjoy Mallik (Aged 31 Yrs) S/O Gopal Krishna Mallik of village Karnagarh, P.S. Salboni, District Paschim Medinipur (iv) Sanjeeb Kumar Badal (Aged 26 Yrs) S/O Joyprakash Badal of 104, GT road Dharamsala Amantran, P.S. Howrah, Dist do (v) Ganesh Kumar Biswakarma (Aged 32 Yrs) S/O Sankarlal Biswakarma of 40 Dharmadas Kundu lane, P.S. Shibpur, District Howrah (vi) Bishnupada Sarkar (Aged 53 Yrs) S/O Lt. Tarapada Sarkar of village Narasinghapur, P.S. Jalangi District Murshidabad under arrest along with following seizure articles i) One white colour INDIGO MANZA vehicle bearing registration No WB 11C/7281 ii) One three fit iron rod iii) One three fit iron rod iv) One iron made knife length about 12 cm. v) One iron made 'Hasua', length about 09 cm. vi) One nylon rope length about 10 fit.

I, A.S.I Sankar Mandal of Tamluk PS do hereby lodge a written complainant against above noted three arrested accused persons and the others notes below, to the effect that on 28.12.2016 at 21.45 hrs. myself along with C/1315, Amit Kumar Jana C/1650, Abdul Rajjak and NVF Joydev Jana was performing night mobile duty over P.S. area vide Tamluk P.S. CC No 6280/16 dated 28.12.2016 and GDE No 1428 dated 28.12.2016. On 28/29.12.2016 night at 22.45 hrs received a information from a reliable secret source that some unknown persons were mobilizing near the back side of Shibtala Bus stopage for committing heinous crime on that locality. So the matter was informed to the O/C and other superiors accordingly and after getting their direction myself along with night mobile duty party and other Officer and force of Tamluk P.S. left to work out the information and approx 23.25 hrs myself along with night mobile duty party accompanied with town night mobile Officer and force reached near the spot as per indication given by the secret source, where I found that some persons were assembled in the back side of Shibtala Bus stand. In that circumstances as per briefing myself along with force advanced towards them. On seeing police party the above noted persons and their other associates tried to flee away but we managed to apprehend the above noted six accused persons. Whatever upon interrogation the six apprehended persons disclosed their name and identity as noted above, they also confessed their guilt and stated that on 28.12.2016 at about 21.55 hrs. they along with their other associates were assembled near back side of Shibtala Bus stand, with deadly weapons for committing dacoity at the surrounding area.

Accordingly myself arrested the above noted three accused persons after preparing proper memo of arrest. Then myself conducted search upon them, recovered and seized i) One white colour INDIGO MANZA vehicle bearing registration No WB 11C/7281 ii) One three fit iron rod iii) One three fit iron rod iv) One iron made knife length about 12 cm. v) One iron made 'Hasua', length about 09 cm. vi) One nylon rope length about 10 fit which is duly signed by local witnesses.

I am to further note here that all the above noted six arrested persons were interrogated by me one after another and all confessed their guilt implicating themselves

and stated that they along with their another two (02) namely Dibyendu and Tapan associates who were managed to escape were assembled there for committing dacoity at Shibtala and its surrounding areas.

In the above facts and circumstances I do hereby produce before you the arrested accused persons named (i) Debendranath Manna (aged 45 yrs) S/O Lt. Chandicharan Manna of village Garkilla, PS-Tamluk, Purba Medinipur, (ii) Pranabesh Jana (Aged 42 Yrs) S/O Krishnapada Jana of village Bahiragarh, P.S. Tamluk, District Purba Medinipur (iii) Sanjoy Mallik (Aged 31 Yrs) S/O Gopal Krishna Mallik of village Karnagarh, P.S. Salboni, District Paschim Medinipur (iv) Sanjeeb Kumar Badal (Aged 26 Yrs) S/O Joyprakash Badal of 104, GT road Dharamsala Amantran, P.S. Howrah, Dist do (v) Ganesh Kumar Biswakarma (Aged 32 Yrs) S/O Sankarlal Biswakarma of 40 Dharmadas Kundu lane, P.S. Shibpur, District Howrah (vi) Bishnupada Sarkar (Aged 53 Yrs) S/O Lt. Tarapada Sarkar of village Narasinghapur, P.S. Jalangi District Murshidabad and two (02) namely Dibyendu and Tapan persons under proper section of law.
