In producing herewith one arrested person namely Aranjit Shit (31) S/o- Lt. Susanta Shit of Dakshin Paikbarh, Ps- Junput Coastal, Dist.- Purba Medinipur. Along with 04(Four) bottles of sealed Sun Country Sprit, 600ml each bottle, total Worth Rs. 260/- in a Nylon Bag.

I, ASI SK Mafuddin, presently posted at Junput Coastal P.S. do hereby lodged complaint as Suo-moto to the effect that today (06.06.2017) at 17.35 hrs. I received a telephonic information from reliable source during my RT Mobile (evening) duty. After getting the source information myself along with force rushed at Faridpur Near Alatherput Bridge, beside the right side road - Contai Pitch Road and found that the above noted person selling the Country Spirit to the public in a nylon bag. On saying Police party the customers are fled away but After chasing I apprehended Aranjit Shit (31) S/o- Lt. Susanta Shit of Dakshin Paikbarh, Ps- Junput Coastal Dist.- Purba Medinipur. And on interrogation he confessed that the above noted Country Spirit with his possession for sale. Accordingly I told him to produced valid documents in support of that liquors but he failed to produce any valid documents in favor of that liquors. So I taken him in custody and I seized 04(Four) bottles of sealed Sun Country Sprit, 600ml each bottle, total Worth Rs. 260/- in a Nylon Bag with proper seizurelist and labeled.

Under the above fact and circumstances I therefore pray that a case may kindly be started u/s 46A(C) B.E. Act. against Aranjit Shit (31) S/o- Lt. Susanta Shit of Dakshin Paikbarh, Ps- Junput Coastal Dist.- Purba Medinipur.
