Sir,

In producing herewith arrested accuse namely Sanjoy Hazra @ Susanta Hazra (37Yrs) s/o Gokul Hazra of Harduachak P.S. Moyna Dist. Purba Medinipur, (owner of illegal I.D liquor shop cum seller . I SI Pranab Samanta . Samanta of Moyna P.S. do here by lodged complaint against Sanjoy Hazra @ Susanta Hazra (37Yrs) s/o Gokul Hazra of Harduachak, P.S. Moyna Dist Purba Medinipur, to the effect that on 22.03.17 at 18:15 hrs. ASI Ashim Mukherjee duty officer of Moyna P.S. received secret information that, illegal sale of I.D liquor is going on at Harduachak area under Moyna P.S. This has a reference to Moyna P.S. GDE No 900 dtd.22.03.17.

I have been directed to work out the information and accordingly myself along with C/ 1486 Goutam Nandi, C/555 Amit Bhowmik both of Moyna P.S who were already detailed for night Mobile duty vide Moyna P.S. C.C No. 759/17 dated 21.03.17 left for to work out the information.

On 22.03.17 at 06:45 hrs, myself accompanied with force reached at Harduachak and identified the house cum liquor shop and held raid at the liquor shop of Sanjoy Hazra @ Susanta Hazra Seeing police some persons who were seating and consuming I.D liquor (cholai) started to flee away but shop owner was apprehended, It revealed that the accused Sanjoy Hazra @ Susanta Hazra is selling unauthorized liquor (Cholai) to consumer violating the law of the land relating to such stock and sale governed in the Bengal Excise Act.

On 22.03.17 in between 07:05 hrs, to 07:45 hrs. searched the shop and found approx 20 (twenty) liters I.D. liquor (cholai) in a plastic jerkin valued Rupees 70/- (seventy) per liter approx.(Total valued Rs 70 X 20 =Rs.1400/- approx), which I seized duly signed by the seller and Police witnesses, as no local public person turned up on request. Sample was taken on the spot duly sealed and labeled by me.

In spite of my several request the said shop keeper Sanjoy Hazra @ Susanta Hazra could not be able to produce the license or any valid document for selling those liquor and confessed that he actually stocked ID liquor (Cholai) at his house cum I.D Liquor shop under Mouza Harduachak PS Moyna and selling illegally. Sanjoy Hazra @ Susanta Hazra continuing this illegal business since long causing loss of Govt. revenue. Hence was taken into custody after issuing memo of arrest duly signed by him , as he violated the provision of sec 18 (I) of Bengal Excise Act and he committed an offence u/s 46 A ( C ) of Bengal Excise Act, 1909.

Under the above circumstances I request you to start a specific case against Sanjoy Hazra @ Susanta Hazra (37Yrs) s/o Gokul Hazra of Harduachak, P.S. Moyna , Dist. Purba Medinipur (owner of the I.D liquor shop cum seller) and arrange for its investigation.
